Remarks:

Reference is made to the announcement of Changsha Broad Homes Industrial Group Co., Ltd. (the "Company") dated 30 August 2021. The opening balance as at 31 August 2021 was 122,035,400 H shares and 365,604,000 Unlisted Domestic Shares, amounting a total of 487,639,400 issued shares. Following the conversion, the H shares increased by 187,779,000 shares (an increase of 38.51% of total number of shares in issue), while Unlisted Domestic Shares decreased by 187,779,000 shares (a reduction of 38.51% of total number of shares in issue). The total number of issued shares of the Company after the conversion remains unchanged, comprising of 309,814,400 H shares and 177,825,000 Unlisted Domestic Shares.

We hereby confirm to the best knowledge, information and belief that, in relation to each issue of securities as set out in Section I, it has been duly authorised by the board of directors of the listed issuer and, insofar as applicable:

- (i) all money due to the listed issuer in respect of the issue of securities has been received by it;

8. *The closing balance date is the date of the last relevant event being disclosed.*

9. *Items (i) to (viii) are suggested forms of confirmation which may be amended to meet individual cases.*

10. *“Identical” means in this context:*

- *the securities are of the same nominal value with the same amount called up or paid up;*
- *they are entitled to dividend/interest at the same rate and for the same period, so that at the next ensuing distribution, the dividend/interest payable per unit will amount to exactly the same sum (gross and net); and*
- *they carry the same rights as to unrestricted transfer, attendance and voting at meetings and rank pari passu in all other respects.*

11. *SEHK refers to Stock Exchange of Hong Kong.*
